NOTICE TO BIDDERS:

The following revisions and / or clarifications shall be made to the bidding requirements and contract documents. Revise and amend the documents for the above-named project in accordance with this addendum. The bid shall reflect these addendum changes and each bidder shall make reference in their bid to this addendum.

All bidding requirements and contract documents shall apply to this addendum as originally indicated in the applicable portions of the contract documents, unless otherwise modified by this addendum.

GENERAL

A. THE FOLLOWING ITEMS ARE ISSUED AS RESPONSES TO PRE-BID REQUESTS FOR CLARIFICATION SUBMITTED BY THE BIDDERS:

Question: From Desmond Poulson First Group.com "There is a pricing section for "Non-Conforming Vans" but no mention of requirements for these drivers and vehicles. So, unless the school district requires Non- Conforming Van drivers to have Commercial Drivers Licensees, I recommend adding Clarifying Language so potential bidders are not confused and so its fair, competitive bid for the school District.

Answer: The District requires all drivers have a Commercial Driver's License/ School Bus Certificate.

Questions: From Ken Pittman Durham School Services Attached are questions we have regarding the bid.

- 1. Can you provide a current Fleet list?
- 2. Please provide the number of conflicting and non-conflicting trips to date.
- 3. It states in the document that the district requires the contractor to provide additional buses. What size buses are required?
- 4. Please provide he miles and hours for each route.

- 5. Can a contractor submit bid which utilities only the district fleet?
- 6. Does the district have sufficient buses to meet the 10% requirement for spare buses or would these buses be required of the contractor?
- 7. What fuel types are current buses
- 8. On page 9, section 2.4.2 it states," contractor shall pay each driver employed to provide services under this agreement at least sixteen dollars (23) per hour. Please clarify if it is \$16 or \$23.
- 9. Is it the districts intent in issuing this bid to hire a private contractor to operate home to school transportation for the district, to include driver and office staffing? If so, are current district staff personnel eligible to be hired upon the interview process?
- 10. Please provide driver wage scale.
- 11. What is the required number of activity buses per the bid? Is the contractor required to provide these, or are there sufficient district buses for this purpose?
- **Answer**: 1. Yes, we are providing Exhibit G, the current fleet list along with the contractor fleet see attached.
 - 2. We had a total of 76 Non conflicting field trips and 153 Conflicting field trips.
 - 3. The contractor to provide 4 conventional buses and 2 Transit buses with HVAC.
 - 4. Hours per route are up to 5 hours, see Exhibit G for miles per route.
 - 5. All bidders must provide a bid that includes district vehicles as well as contractor Provided buses.
 - 6. The buses required are a combination of fleet owned by the district as well as contractor provided buses.
 - 7. See attached Exhibit G current fleet list.
 - 8. There is a clerical error on page 9 section 2.4.2 the correct amount is Twenty-Three Dollars (23).
 - 9. The district currently hires a contractor to operate home to school transportation for Special education students. This included all drivers, Manager, Trainer, dispatcher, and Mechanics. Employees are not district employees and are eligible to be hired upon the interview process.
 - 10. The driver wage scale is \$23-\$27 dollars an hour.
 - 11. See the attached Exhibit G for activity buses, some of which are provide by the contractor.

Question: As a note, the transportation bid is not listed on your website as a current bid opportunity or on the Colbi Secure bids site, just as a manual.

Answer: The website will be changed to read "Bid Opportunity".

SAUGUS UNION SCHOOL DISTRICT NOTICE TO BIDDERS FOR PUPIL TRANSPORTATION SERVICES – BID NO. 23-24-7230

- 1. Notice is hereby given that the Governing Board ("Board") of the Saugus Union School District, ("District"), will receive sealed bids for a contract for pupil transportation services. Currently the District transports approximately 180 special education students Monday through Thursday and approximately 140 special education students on Fridays. There are currently 13 routes. The District also requests the availability of activity buses for field trip transportation.
- 2. Sealed Bids will be received until **3:00 p.m., May [29], 2024**, at the District's administrative offices, 24930 Avenue Stanford, Santa Clarita, CA 91355, at which time the bids will be opened and publicly read aloud. Any bid that is submitted after this time shall be deemed non-responsive and returned to the bidder.
- 3. All bids shall be on the forms provided by the District. Each bid must conform and be responsive to all pertinent Contract Documents including, without limitation, the Notice to Bidders, the Instructions to Bidders, this Bid Form and its attachments and the form of Agreement and its attachments.
- 4. A mandatory pre-bid conference will be held on May [14], 2024, at 2:00 P.M. at the District Office Maintenance Department, 24930 Avenue Stanford, Santa Clarita, CA 91355.
- 5. Contract Documents may be obtained from [Suki Huitink], Maintenance Department or via https://www.saugususd.org/Maintenance-and-Operations
- 6. The Board reserves the right to reject any and all bids and/or waive any irregularity in any bid received. Unless otherwise required by law, no bidder may withdraw its bid for ninety (90) days after the date of the bid opening.
- 7. The District shall award the bid, if it awards it at all, to the responsive bidder who the District determines can best provide pupil transportation services at the lowest possible cost consistent with proper and satisfactory service. The District reserves the right to let the Contract to other than the lowest bidder as authorized by Education Code section 39802.
- 8. The contract will contain a liquidated damages clause.

remain in effect notwithstanding any rejection of Contractor driver pursuant to this Agreement. The adequate number of drivers shall be determined by the District subject to the following formula: (a) the number of Bus Routes plus ten percent (10%) cover driver ration; and (b) the sum number of Bus Routes and Special Trips. Should Contractor fail to provide sufficient drivers, the District may secure such services and reduce the Contractor's next invoice by the cost of such services.

2.4.2. <u>Driver's Wages</u>. Contractor shall pay each driver employed to provide Services under this Agreement at least <u>Twenty-Three Dollars</u> (\$23) per hours, exclusive of Contractor provided benefits, subject to the same escalator provided for in the "Rate Adjustment" section herein. Driver's performing services under this Agreement shall be paid a minimum of five (5) hours per day, except when a work assignment is cancelled.

2.4.3. Minimum Qualifications of Drivers.

- 2.4.3.1. Contractor shall employ only qualified drivers trained and licensed in accordance with applicable California and federal laws to operate the vehicles that will be used to provide transportation services under this Agreement, including, without limitation: training sufficient to obtain a School Bus Driver's Certificate; training to ensure proficiency in the type(s), brake system(s), or transmission(s) of vehicle(s) to which any driver might be assigned; specialized training required to transport student with disabilities, medical, or other special needs, to the extent that a driver will be assigned to a route in which any such students will be transported. Prior to a driver employed by the Contractor performing Services under this Agreement, and at the District's discretion, drivers may be required to participate in two (2), four (4) hour training sessions regarding orientation, pupil management, and the District's disciplinary standards.
- 2.4.3.2. <u>Continuing Training.</u> Contractor shall require every driver to complete the following continuing training each year:
 - 2.4.3.2.1. If a driver performing Services under this Agreement is involved in an accident or incident that the District in its discretion deems to be preventable, the affected driver shall participate in four (4) hours of mandatory behind the wheel training. The Contractor shall not allow the affected driver to perform transportation services under this Agreement until proof of such retraining is provided to the District.
 - 2.4.3.2.2. Any training required to maintain any licenses or permits required under this Agreement.
 - 2.4.3.2.3. Any training other training mutually agreed upon by the District and the Contractor.
