NOTICE TO BIDDERS:

The following revisions and / or clarifications shall be made to the bidding requirements and contract documents. Revise and amend the documents for the above-named project in accordance with this addendum. 1. GENERAL

A. THE FOLLOWING ITEMS ARE ISSUED AS RESPONSES TO PRE-BID REQUESTS FOR CLARIFICATION SUBMITTED BY THE BIDDERS:

1. Question: We are interested in bidding for the work to be done at Bouquet Canyon, would it be possible to use a C-15 license in place of B, C-27 or C61.
Answer: According to the Contractors State License Board (CSLB), a contractor must either have their C-27 license or their C-61/D12 license to legally install turf.

INVITATION (ADVERTISEMENT/CALL) TO BID

NOTICE IS HEREBY GIVEN that the Saugus Union School District, acting by and through its governing board ("District"), will receive sealed bids for the **Bouquet Canyon School New Synthetic Turf Project**. Value of the contract is estimated at \$125,000.

The project generally consists of the construction of: Provide and install Artificial Turf and modify existing Irrigation at Bouquet Canyon Elementary School. The successful Contractor should have prior experience installing artificial turf fields. Please see Bid Documents for more information.

To bid on this Project, the Bidder is required to possess one or more of the following State of California Contractor Licenses: **B, C-27, or C-61/D-12**

The District will only receive bids submitted electronically. Electronic bids will be received until **10:00 AM, Tuesday, November 14, 2023** only at the link provided in the Instructions to Bidders, after which time the bids will be opened on Zoom, <https://us02web.zoom.us/j/81197107102> or call 877 853 5247 US Toll-free / Meeting ID: 811 9710 7102.

Each bidder is solely responsible for timely submission of its bid; the District is not responsible for any technological issues in a bidder's ability to timely submit its bid or portion thereof. Any bid that is submitted after this time shall be nonresponsive.

The successful Bidder and its subcontractors shall pay all workers on the Project not less than the general prevailing rate of per diem wages and the general prevailing rate for holiday and overtime work as determined by the Director of the Department of Industrial Relations, State of California, for the type of work performed and the locality in which the work is to be performed within the boundaries of the District, pursuant to sections 1770 et seq. of the California Labor Code. Prevailing wage rates are on file with the District and are available to any interested party on request or at www.dir.ca.gov/oprl/statistics_and_databases.html. Bidders and Bidders' subcontractors shall comply with the registration and qualification requirements pursuant to sections 1725.5 and 1771.1 of the California Labor Code.

No prequalification is required to be eligible to submit a bid for this project.

Each bid must be submitted on the bid form provided in the bid documents and accompanied by a satisfactory Bid Bond executed by the bidder and surety company, or certified check, or cashier's check in favor of the Saugus Union School District or cash, in an amount equal to ten percent (10%) of the bid. **On the same day as the bid opening, Bidders must deposit in the mail the original of the Bid Bond, cashier's check, or certified check.** The successful Bidder shall be required to furnish a 100% Performance Bond and a 100% Payment Bond if it is awarded the contract for the Project.

The successful Bidder may substitute securities for any monies withheld by the District to ensure performance under the Contract, in accordance with the provisions of section 22300 of the Public Contract Code

The District reserves the right to reject any and all bids and to waive any irregularities or informalities in any bids or in the bidding.
