Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

#### Options

Note that the CAAs could only be administered in-person following health and safety requirements. If it was not viable for the LEA to administer the CAAs in person with health and safety guidelines in place, the LEA was directed to not administer the tests. There were no other assessment options available for the CAAs. Schools administered the Smarter Balanced Summative Assessments for ELA and mathematics, other assessments that meet the SBE criteria, or a combination of both, and they could only choose one of the following:

- Smarter Balanced ELA and mathematics summative assessments;
- Other assessments meeting the SBE criteria; or
- Combination of Smarter Balanced ELA and mathematics summative assessments and other assessments.

## Percentage of Students Meeting or Exceeding the State Standard on CAASPP

The 2020-2021 data cells have N/A values because these data are not comparable to other year data due to the COVID-19 pandemic during the 2020-2021 school year. Where the CAASPP assessments in ELA and/or mathematics is not the most viable option, the LEAs were allowed to administer local assessments. Therefore, the 2020-2021 data between school years for the school, district, state are not an accurate comparison. As such, it is inappropriate to compare results of the 2020-2021 school year to other school years.

## Professional Development

Our professional development focuses on providing support for our new and returning teachers. The Teacher Induction program provides support through mentor teachers to our first and second year teachers. All teachers continue to receive training in Professional Learning Communities (PLC), Technology, Curriculum, Next Gen Math, Illuminate, Constructing Meaning (CM) and Systematic ELD instructions. All through the year teachers attended workshops that focused on the use of Chromebooks and Interactive Flat Panels (IFP) in classroom instruction. Our teachers on special assignment (TOSAs) continue to provide support in the areas of Technology, Arts Integration, NGSS, Physical Education, Systematic ELD and academic vocabulary instruction. We continue to work on our understanding of the new California Standards. We are paying special attention to Mathematics, through an understanding of the scope and content of the targets, the depth of knowledge (DOK) level(s) for each target and assessment/mastery evidence required for each target. We are also working on a coherent sequence of instruction of the ELA standards.

In addition to these professional development opportunities, the teachers' work calendar includes three professional development days and weekly collaborative instructional planning times.
